Executive summary

- Total assets under management of the 500 managers included in the ranking totalled US\$ 62 trillion at the end of 2009, up 16.1% from the end of 2008.
- BlackRock took the first position. Allianz Group ceded its second position to State Street Global and ranked third in 2009. The merger between BlackRock and Barclay Global Investors means that the top ranked manger is 75% larger than the second ranked.
- Assets under management of North American managers were US\$ 30.6 trillion at 2009 year end, an increase of 27.9% from the previous year. The assets managed by European managers grew 5.8%, ending on US\$ 24.1 trillion for the year.
- The Top 20 managers' share of the total assets increased from 38.3% to 40.2%.

- US managers in the Top 20 managed 62.7% of total AuM for that group, while the remaining 37.3% was controlled by European managers.
- By number bank-owned asset managers continued to dominate the Top 20 while the number of independent asset managers grew in that group. Insurer-owned asset managers remained static.
- Assets under management of managers from developing countries rose from 1.9% of the total assets in 1999 to 4.0% in 2009. During the same period, Japanese managers' AUM were down from 13.2% to 6.9%.



Total value of assets managed


Split by manager domicile

- North American managers' assets increased the most in 2009 (27.9%), followed by European managers (5.8%). Assets managed by Japanese managers remained largely static.

Split by segment




Total value of assets managed by top 20

Split by manager domicile




- US managers' assets grew in 2009, while European managers' assets declined.

- The 12 US based managers managed 62.7% of top 20 assets at the end of 2009 (50.8% at the end of the previous year).

Top 20 managers by manager type




• At the end of 2009, bank-owned asset managers remained predominant in the top 20, followed by independent managers and insurer-owned asset managers.






Total value of AUM of leading passive managers with annual growth rate
